Introduction

J-Smart Pro has been developed and designed for the efficient and productive identification of CVD and HTHP laboratory grown diamonds, either as loose stones or in diamond-set jewelry. Laboratory grown diamonds (LGD) are visually indistinguishable from natural diamonds and the supply pipeline is contaminated by the undisclosed intrusion of LGD into every part of the Jewlery industry.

Because all concerned interests in the jewelry industry desire to represent their products fairly and honestly, it is necessary to have some type of device that detects laboratory grown diamonds to prevent any possible confusion or misrepresentation. J-Smart Pro is the latest device designed to identify laboratory grown diamonds. Consumers have a fundamental right to know about the origins of the products that they purchase. J-Smart Pro allows the Retailer, Wholesaler, and Manufacturer to verify the content of the merchandise that they sell.

J-Smart Pro is a machine that can facilitate the screening process for CVD and HTHP laboratory grown diamonds to protect consumers from undisclosed LGD. This manual is a guide in the effective, efficient, and safe use of this instrument. Please review it carefully before the use of the instrument.



*Eye injury hazard descriptions above are valid for for exposures relatively close to the laser. Because the beam spreads, less light will enter the pupil at greater distances. The hazard decreases the farther a person is from the laser, and the shorter the exposure time (e.g., do not deliberately look or stare into the beam). For example, a 1mW Class 2 laser beam is eye safe for unintentional exposures after about 23 ft (7 m), a 5mW Class 3R beam is eye safe after about 52 ft (16 m), a 500 mW Class 3B beam is eye safe after about 52 ft (16 m), a 400 mW Class 3B beam is eye safe after about 520 ft (160 m), and a 1500 mW Class 4 beam is eye safe after about 900 ft (275 m). The J-Smart Pro manufactured by DRC has been designed and developed for the identification of CVD and HPHT laboratory grown diamonds. It has been created with the following functions.

- Detection of both CVD and HTHP laboratory grown diamonds
 - o Diamonds of any shape, including rough or unfinished stones
 - Diamonds from 0.003 carat in weight and larger, approximately .80 .85 mm., (Sieve size +0000 000)
 - o Loose stones (unmounted in Jewlery) or stones mounted in Jewlery
 - o Diamonds in the colour range of D through J-K colour (GIA scale)
- Integrated internal PC with touch screen for all-in-one operations.
- Designed for ease of use by both technical and non-technical staff.
- Intuitive GUI (Graphic User Interface) for click-to-scan features.
- Automatic identification of laboratory grown diamonds.
- Advanced viewing and analysis features utilizing fluorescent, photoluminescent, and phosphorescent screens.
- Automatic storage of every scan in four different viewing modes.
- Large field scanning of a 9 x 5¾ inch area.
- Average scanning time of 60 to 90 seconds.
- Keep the device dry and away from liquids to avoid electrical shorts and shocks.
- The J-Smart Pro is not heat-resistant: please keep it away from radiators and open flames.
- Repairs must be performed only by an authorized service engineer. Unauthorized tampering with the device will void the warranty.
- Do not modify or alter the device.
- Never operate any electrical device if it has a damaged cord or plug, if it is not working properly, if it has been dropped or damaged. Call DRC for technical support.









4 Set Up (no tools are required for assembly)

4.1 Unboxing Guidance

- 1. For unboxing guidance scan the QR code or check the below link & follow the steps one by one as provide.
- 2. https://drcindia.in/unboxing-j-smart/

4.2 Unboxing

- 1. Cut the exterior strapping, any cellophane wrapping and discard (responsibly).
- 2. Remove the top of the package.
- 3. Remove the sides of the packaging exposing the inner foam- cushioned components.
- 4. Separate the contents from the foam packaging.
- 5. We suggest that you keep the box, if possible, for at least 60 days.

4.3 Inventory the Contents

- 1. Lay out all the components
- 2. Check them against the above itemization of components and trays
- 3. Make note of any items that are missing or damaged
- 4. Contact the DRC Support Team as noted on the laminated worksheet to arrange for replacements to be sent and possibly a claim request from the carrier

4.3.1 Set Up the Machine

- 1. Set the J-Smart Pro on a study table, countertop, or desk
- 2. The surface should be flat and level

4.4 Preparing for Operation

- 1. Plug the Power Cord into the machine and then into a grounded outlet (as an additional safeguard, a surge-protected power bar is good protection)
- 2. Screw the Wi-Fi antenna into the threaded outlet on the left side of the J-Smart Pro machine
- 3. Remove the cap from the purple flash drive and plug it into one of the USB ports on the right-hand
- 4. side of the J-Smart Pro. This is a security device. The machine will not operate without it.
- 5. The open USB ports can be used to connect additional hardware like a backup hard drive or bar code scanner. The left-hand side of the machine has a plug for a hardwired network cable and a HDMI port if you want to attach a remote video monitor. If you have questions regarding these connections, please contact DRC Support.
- 6. Insert batteries into the mouse (generally a single AA battery) and the keyboard (generally two AAA batteries). Note: the dongle that provides a relay signal to the mouse and keyboard is sometimes housed inside of the mouse. They may also have on-off switches. Turn them on.
- 7. Plug the dongle into one of the available USB ports on the right side of the J-Smart Pro
- 8. Open the front panel of the J-Smart Pro machine and seat the sliding platform tray into position. This is a one-time process.

4.5 Initial Start-Up

- Press the large power button on the right-hand side of the J-Smart Pro machine. You should hear the faint sound of fans running and the button will illuminate. This button powers on the fans and motors inside the machine.
- Press the smaller power button on the right-hand side of the J-Smart Pro machine. The button will illuminate. This button powers the internal computer.
- You should now see the initial boot up of Windows on the LCD screen. Allow it to run until the home screen becomes visible.







- Click on the Network Connection icon on the bottom menu bar and proceed to select your approved Wi-Fi network.
 - a. Note that this instrument does not require an internet connection to operate on a regular basis, but a connection is required for Support, Service, and updates.
 - b. Note also that once you have an internet connection, Windows X may automatically connect to the internet to update Windows. If it does, please allow the update to take place before operating your J-Smart Pro.





5 J-Smart Pro Program Desktop

The opening desktop for the DRC software program is arranged for easy operation.



- 1. DRC automatically assigned lot number for every scan.
- 2. Open field for customer supplied intelligent number.
- 3. Open detail button (Down Arrow): clicking opens the optional scanned merchandise information fields.
- 4. Support Button: click to get help or to search previous scans by date or lot number.
- 5. Report Button: click to search previous scans by date or lot number.
- 6. Setting Button: click to customize your setting.
- 7. Calibration Button: click to calibration when to start a machine or change merchandise category.
- 8. Merchandise Category Button: click to open and select the category.
- 9. Scan Button: click to start scanning.
- 10. Result Button: click to open different merchandise view in new window.
- 11. Reset Button: click to simply reset the camera to a live merchandise view.



6 Preparing for Merchandise Scanning

6.1 Step: 1

- The J-Smart Pro machine must be set to the right merchandise category so that the camera can accurately capture and diagnose the image of each item that it scans.
- Look at the menu icon on the bottom right-side of the J-Smart Pro desktop. Click on the upper arrow above menu button and click on the first icon from the bottom. Single click on this and it will expand to the left with seven (7) different categories of merchandise.
- To scan successfully, the machine must be set to the correct category of merchandise you are evaluating.



Necklace/Earing	Earring, Pendant, Flat Bracelet Icon	This setting is for assorted jewelry items including earrings, pendants, straight line bracelets, and other assorted items. • Use the black foam-covered slotted tray for this setting.
Bangle Auto	Bangle Bracelet Icon	This setting is for bangle bracelets with stones covering most of the surface of the bracelet. This setting makes 6 individual scans. • Use the automated bangle bracelet tray, plugging it in first.
Diamond	Loose Diamond Icon	This setting is used for loose diamonds. Scatter or arrange them on the tray. • Use the flat tray with grid lines.
Ring	Ring Icon	This setting is used for rings. The machine scans only the visible area when looking down. Rings with diamonds on the side stones or diamonds on the gallery may need multiple scans.
Eternity Auto	Eternity Ring Icon	This setting is for eternity rings, rings with diamonds down the shank or hoop earrings. This setting makes 6 individual scans. • Use the double mandrel tray and plug it in first.
Bangle	Non-Moving Bangle, Watch Icon	This setting is for bangle bracelets that may only have stone-set sections on the top or for watches. • Use the bangle bracelet tray, DO NOT PLUG IT IN.
Eternity Manual	Non-Moving Ring Icon	This setting is for eternity rings or wide bands with diamonds on the top of the ring. • Use the eternity ring tray, DO NOT PLUG IT IN.




6.2 Step: 2: Calibration

At the beginning of each day or after a session where you restart the DRC J-Smart ^{Pro} desktop, you will need to calibrate the machine. Whenever you start the J-Smart ^{Pro} program, perform a calibration by clicking on the button as shown below. It takes seconds.


- Click on the "Calibration" icon shown as picture.
- The machine will automatically perform a calibration alignment of the tray within the view of the camera.
- Within approximately 10 to 15 seconds the process is done and a popup on the screen will tell you that the calibration process has been completed.

6.3 Merchandise Placement

- Select a tray for the appropriate placement of your merchandise.
- Diamond set earrings and pendants can lie on the same black foam tray that is used for rings.
- Merchandise should be contained within the boundaries of the numbered areas
 using a jewelry tray. Loose diamonds should be placed within the alpha-numeric
 grid. Outside of these areas, merchandise is beyond the field of vision of the optics.



- CAUTION: When scanning jewelry, it is best to conceal any tags that are attached. J-Smart uses light to perform its analysis. Jewelry tags are highly fluorescent which disrupts and slows the scanning process.
- Do your best to conceal these tags or turn them on edge so that are not scan able by the instrument.
- Any use of other displays or jewelry box inserts to scan diamond set jewelry will generally be unsuccessful. Most of these inserts are made of highly fluorescent materials which will disrupt the scanning process.
- When there are large tags or display boxes showing on the tray the length of the scan time will increase as the machine tries to scan them because of their fluorescence.





7 Scanning Merchandise

7.1 Preparing to Scan

- Note that the most accurate scanning results are achieved with merchandise that is clean.
- Scanning is done by means of an overhead optical system. It is not required that the diamond tables be strictly horizontal (parallel to the platform), but diamonds set into surfaces (sides or into gallery work) that are not visible when looking straight down will not be scanned.
- Repositioning the jewelry for additional scans may be required.
- Try to conceal jewelry tags by tucking them into ring slots or through the slots intro the back of the provided tray. Paper, plastic, and Mylar tags are by their nature highly fluorescent which disrupts the scanning process.



Similarly, scanning Jewlery while it is mounted onto jewelry pads is not effective.

- 1. Select the appropriate type of tray for the merchandise that you want to scan.
- 2. Place it on the tray and place the tray on the sliding platform.
- 3. Push the tray fully into the machine until it will go no further.
- 4. Close the machine door. The door must be closed for the machine to operate correctly. Accurate scanning cannot take place with the door in an open position.

Always make certain that the proper merchandise category is selected (note Step 3). Scanning may not be accurate, and the clarity of the merchandise scanned may not be in focus without the proper setting.

- 1. Rings with narrow shanks can be scanned using the Ring/Jewelry tray.
- 2. The same tray should be used for pendants, earrings, necklaces, broaches, or straight-line bracelets.
- 3. The motorized bracelet tray automatically revolves 360 degrees while taking six (6) scans. The same tray can be used with the non-motorized setting to scan



- 4. without any rotation. It can then be used for watches or other bracelets.
- 5. The motorized eternity ring tray automatically revolves 360 degrees while taking six (6) scans. The same tray can be used with the non-motorized setting to scan without any rotation. It can also be used for hoop earnings.





7.2 Scanning

- Using the wireless mouse or the touchscreen, double-click on the side arrow in menu icon if bottom horizontal slider is off.
- Click on the scan icon.
- Seconds after you click on the icon, a rolling circle of dots will appear in the centre of the screen. This indicates that the scanning process has begun.
- The scanning process generally takes approximately 45 to 90 seconds.
 - a. You will see a rotating circle of dots while the scan is taking place.
 - b. For approximately 20 seconds, once the scan button is clicked there will be a shrill whining sound, like an ultrasonic cleaner. This sound is made by highly specialized lighting of the J- Smart ^{Pro}.
 - c. Once the sound is done, the scrolling dots will remain while the computer compares the digital output of the stone(s) scanned and compares it with our database of known diamond results.





7.3 Scanning Tips



- WARNING. Always set the Scanning Category to the appropriate scanning target using the selection icon in the upper right-hand corner of the desktop. If the correct setting is not used, the focal length of the digital camera will be incorrect and scanning results may not be accurate.
- Scanning will be most accurate if the items scanned are centred in the display field as much as possible.
- When scanning Jewlery, it is always advisable to minimize the visibility of Jewlery tags. These tags are made with materials that tend to be highly fluorescent and they can affect the operation of the machine.

7.3.1 Scanning loose diamonds: from 0.003 carats and larger of any shape

- Use the loose diamond tray and adjust the scanning category to loose diamonds before scanning.
- Clean diamonds are more effectively scanned
- Loose (or mounted) diamonds do not need to be oriented in any particular manner. They can sit face up, table down, on edge, or at any angle so long as light can be reflected off a surface of the stone.
- For the most effective scanning, diamonds should lie in a single layer, preferably without touching or overlapping.



• For the best and most accurate results, diamonds should not be scanned while in a polybag or display box. The layer of plastic over the diamond can affect the results of the scan.

7.3.2 Scanning Mounted Diamonds: from 0.003 carats and larger of any shape

- Use one of the flat felt slotted trays for rings and other Jewlery.
- Clean diamonds are most effectively scanned.
- Jewlery tags are highly fluorescent and can interfere with the scanning process. As much as possible, conceal them from the scanning field. One of the ring trays has slots that are pierced through the back of the tray so that tags can be pushed through the slot and concealed.
- Diamonds can be scanned regardless of the angle of the stone in the setting. Diamonds sitting on their side with only the girdle exposed can be scanned.
- Jewlery should be removed from any box or case. Generally, the materials used for these cases are highly fluorescent and distort the results. Additionally, displays change the height of the Jewlery item and can therefore alter the focal distance to the digital camera.

8 Observing and Interpreting Scanned Results


8.1 Understanding Scan Results

- After Jewlery or Loose Stones are scanned, J-Smart Pro software automatically identifies laboratory-grown diamonds or stones that may be LGD but require further investigation with alternate viewing screens.
- These stones are identified by means of <u>flashing boxes and circles</u> that surround the diamond.
- The flashing shapes are a means to easily identify diamonds that require the operator's attention.
- They may indicate identified laboratory grown diamonds or stones which require further review using supplemental screens.
- A key to these geometric identifiers is illustrated below.




Diamonds in green boxes with Blue Circles are identified as Laboratory grown diamonds. No Further Examination is required.

8.2 Basic Scanning Diamond Identification



This mark indicates a confirmed CVD or HTHP laboratory grown diamond. No further examination is required.



This mark identifies a diamond that requires review under an internal or external fluorescent lamp. If this stone glows from faint to intense fluorescent color as the examples that are shown below, it can be considered natural. Shown below are instances of fluorescent colours.

More than 30% of all natural diamonds exhibit some degree of fluorescence while nearly all laboratory grown diamonds are inert or display only extremely faint fluorescence.



Common Natural Diamond Fluorescence




Natural Rough Diamond Fluorescence

This mark indicates that the machine cannot automatically identify this stone. To identify this stone, use the quad-screen view to simultaneously see comparative views as scanned and under fluorescent, phosphorescent, and photoluminescent screens.



If diamonds look like these examples in both the phosphorescent and photoluminescent views, they are laboratory grown diamonds.

8.3 Advanced Scanning Interpretation

• Those diamonds whose scan displays a 'Recheck' box can often be identified through advanced scanning interpretation or re-check again after cleaning the diamond and placing separately. Utilize these techniques if a diamond is indicated with the 'Rescan or Re-check' box surrounding it.




- To accomplish this, utilize a screen view that displays all four viewing modes. You can view these screens by clicking on the 'Result Icon. These are the views that are available.
- Original (as scanned)
- Fluorescent
- Phosphorescent
- Photoluminescent
- Note that each of these views is stored as a separate *.JPG file within the file folder stored as the Lot Number.





8.4 Navigating the Quad-Screen


This view of scanning results allows the user to view results under multiple wave lengths at the same time to allow for in-depth analysis.



8.5 Stage One Advanced Analysis

8.5.1 Compare the photoluminescent and phosphorescent views.

- If a stone is radiating any of the illuminated colours like the examples below and the stone glows in both screens, consider the diamond to be laboratory grown. These colours may be intense or muted.
- Colours in each of the screens may be similar but may also be different from one screen to the other.



8.6 Stage Two Advanced Analysis

• Examine the rescan or recheck stones that require in-depth analysis in the **Photoluminescent screen**. If they radiate any of the colours shown below and they **do not** show any **Fluorescence** in the **Fluorescent** view (or when viewed under an external fluorescent light source) or colours of the examples below, they are **laboratory grown diamonds**.




Examples of natural blue fluorescence



8.7 Sample Pendant

• We have provided a sample pendant with the machine that contains three stones two of them are synthetic stones, and one simulant stone.



2. Photoluminescence

3. Phosphorescence

- The Top and Bottom Stone which is marked with "Green Box and Blue Circle" is a Synthetic Stone. In advance Screen, it shows Turkish blue Lumination on photoluminescence (Screen 2) and phosphorescence (Screen 3) view.
- The Middle Stone which does not have any box or mark is a Simulant Stone and in advance the screen, it won't have any Lumination on any of the advance screens.



9 Retesting

• An Important Notation.

- Laboratory-grown diamonds, particularly, CVD-grown stones are continuing to evolve at a rapid rate of development. The formulae for these stones literally change on a daily basis as manufacturers strive to improve or obscure the origin of their laboratory-grown diamonds. Therefore, we encourage users to go beyond automatic testing if there is any question about the origin of a particular diamond.
- It can be helpful to remove a loose diamond or Jewlery with an identified diamond from the original scanning tray and to scan it by itself or with other suspect items. Look for differences in the results and observe these stones in different views.
- DRC updates the software for J-Smart Pro as we continually work to provide the most accurate analysis of diamonds.
- Additionally, our Support Team and our Research and Development Team is available to assist users in the testing and analysis process. Contact our Support Team for further assistance.

10 Scanned Image and Data Storage

Every scan on the J-Smart Pro is saved. Additionally, every scan is saved as a unique data folder of four separate images: as-scanned, fluorescent, phosphorescent, and photoluminescent. These files are saved in *.JPG format.

- I-Smart comes with 500GB of storage on its hard drive.
- Additional storage can be realized with the addition of a USB hard drive. DRC Support will assist you in mirroring the storage on both drives.
- Periodically, as the 500GB of storage is filled (typical capacity is over 10,000 images) old files can be deleted or offloaded onto a remote USB flash drive or separate hard drive.
- For purposes of security, you can attach a USB hard drive and safely detach it for secure storage every night.
- Data can also be shared with your system server by means of a Wi-Fi or cable connection.


This data can be of value for reference or reports. Searching this data and configuring it as you require is possible in several different ways.

10.1 Customized Lot Data

The J-Smart Pro software automatically assigns a unique lot number to every scan. However, the user can also provide merchandise information that will be stored with the scan. If details about the merchandise needs to be associated with the scan and stored, manual input is allowed.

From the J-Smart Pro Home Screen on the Desktop:

- Automatic Lot (batch) number is always the default reference label.
- The user can assign their own number by (single) clicking the file icon to the right of the Lot Number.






Data must be entered before the scan takes place. Adding information is a 4-step process

Customer Assigned Information Process:

- 1. Click on the Down Arrow to open a drop-down data window.
- 2. Input data in the fields where it is desired.
- 3. Click the Save button in the bottom left corner of the drop-down window.
- 4. Click the close icon in the upper right corner of the drop-down box to close.

Your data is now stored with the information that you desire.

Data can also be added through use of a bar code scanner using the USB or serial port. Ask the DRC Support Team to assist you in aligning the scanned information.


10.2.1 Finding Your Data


Begin the process of locating archived data by clicking on the Reports Icon. This opens the Reports detail screen.




10.2.3 Step One: Selecting an archived

- Then a preview of the lot will appear on the twoscreen view on the left with 'as scanned' and 'fluorescent' views.












10.4 Print options with J-Smart Pro

11.1 Warranty Claim Process

12 Troubleshoot

12.1 If the machine is not working.

- Plug in the right power supply as specified in the operation manual. Switch on the "Device".
- Inspect the diamond/ jewellery tray to see if it is properly inserted into the machine.
- Switch on the software and wait for the device to get started.
- Wear gloves while mounting the jewellery so as to keep it free from masking, coating, greasy or dusty surface.
- Make sure that diamonds are properly boiled at 250 degrees Celsius for 30 minutes with a solution mix H2So4 30% and HNO3 70% for testing the diamonds appropriately.
- Slide the tray inside the device until it gets locked.
- Initiate the scanning process.
- This device has been invented to detect laboratory grown diamonds only.
- The machine should be switched off for 15 minutes in every four hours for better performance.

12.2 I have laboratory-grown diamonds, but some of the stones are not detected by J-Smart Pro.

- Ensure you have followed all the operation instructions correctly.
- It is common to face such a scenario; we have gone through them too. After a deep analysis we have found that these diamonds are not lab-grown but natural diamonds.
- There are chances that they were accidentally replaced during the manufacturing process or the grading process.
- There might be a possibility of them being coloured diamonds.
- There might be a chance of them not being properly cleaned or masked.
- Scan it again, if the results achieved are the same, click on the "Expert Assistance" button on the software to approach our technical team. They will provide you with the necessary assistance.

12.3 My diamonds are natural but J-Smart Pro detects few of them as Lab-Grown.

- Ensure you have followed all the operation instructions correctly.
- It is common to face such a scenario; we have gone through them too. After a deep analysis we have found that these diamonds are not Lab-Grown but natural diamonds.
- There are chances that they were accidentally replaced during the manufacturing process or the grading process.
- They may be a possibility of them being coloured diamonds.
- They might be a chance of them not being properly cleaned or masked.
- Scan it again, if the result remains the same, click on the "Help" button in the software and our technical team will provide you with the necessary assistance.

13 FAQ

13.1 What does J-Smart Pro do?

• The sole purpose of the J-Smart ^{Pro} is to uphold consumer confidence in the natural diamond industry. Most of the diamonds or diamond jewellery purchased today is for emotional occasions like weddings, engagements, anniversaries or birthdays, so on and so forth. The consumers should know what they are buying. Lab-Grown diamond may have a place in the jewellery segment but mixing or unethically selling Lab-Grown diamonds with the tag of it being a Natural diamond is playing with the customer's emotions, resulting to lack of consumer confidence in the industry. This concern was shared with us by many players of the fraternity. Thereafter as being a part of this industry we have taken this situation as a challenge and invented J-Smart ^{Pro} as a result.

13.2 Why J-Smart Pro?

- Most of the detection tools or devices available in the market are either very costly or are limited to specific sizes, shapes, speed, accuracy or the device is being made for specific clientele alone. Most devices can only detect TYPE-IIA which requires further testing and analysis to be done in the Lab.
- It requires a lot of time and energy to make sure that all purchases are Natural Diamonds. After years of research of the perennial issues, we have consolidated the solution in one single device i.e. J-Smart Pro was developed to detect Lab-Grown Diamonds.



13.3 What size of diamonds it detects?

• J-Smart Pro is a device that detects lab grown diamonds of all sizes from 0.003Cts (+0000 Sieve size) and larger, whether colourless or near to colourless Lab-Grown diamonds.

13.4 What diamond shapes does it detect?

• Any shape is detectable, but for small (below +11) fancy shapes it needs a replaceable attachment.

13.5 Is it type II-Identification, does further identification required?

J-Smart Pro directly detects lab grown Lab-Grown diamonds (Diamond grown in laboratory by HPHT as well as CVD techniques) within all colourless or near colourless diamonds. It does not require further testing as the results are shown on the spot.

13.6 Is it good for rough diamonds also?

• Yes.

13.7 What is the speed?

• Currently, it scans one tray (9-inch x 6-inch) filled with diamonds in about 45-90 seconds.

13.8 How to operate?

• Operating this device is very simple and easily understandable. The operator needs to go through the operation manual before operating J-Smart Pro. For the test, ensure that the right size tools are chosen, colourless diamonds must be properly cleaned/boiled and they should not overlap one another.

13.9 How about after-sales service?

• While designing the machine, we have taken care of using limited parts that require service in the machine. If anything happens to the machine within the warranty period or even after the warranty period, the customer is advised to contact our India support centre.



14.1 Limited Warranty

- Subject to the exclusions, limitations, and conditions set forth below, DRC warrants to the original purchaser of the J-Smart Pro will be free from defects in material and workmanship, when subjected to normal, proper, and intended usage by properly trained and informed users, for twelve (12) months from the date of shipment of the J-Smart Pro to the original purchaser (the "Warranty Period".)
- DRC shall not have any liability if the J-Smart Pro (a) is unable to determine, distinguish or detect whether an item being analysed by the J-Smart Pro is a natural diamond, potential laboratory-grown, processed or treated, or potentially a diamond simulant or (b) makes an inaccurate determination or gives an inaccurate reading as to whether the item is a natural diamond, potentially laboratory- grown, treated, or processed, or is potentially a diamond simulant.
- For any defective J- Smart Pro that is returned to DRC by the original purchaser during the Warranty Period in compliance with the process specified below, DRC will, at DRC 's option, repair or replace the defective J- Smart Pro, or refund the price paid to DRC for the defective J- Smart Pro. A replacement may be a new or refurbished J- Smart Pro in DRC's sole discretion and any such replacement will continue to be subject to the warranty set forth above for the balance of the Warranty Period for the J- Smart Pro initially purchased.

14.2 Exclusion

- J- Smart Pro will not be deemed defective and DRC will not have any obligation to repair or replace a J- Smart Pro, or refund the price paid for the J- Smart Pro as a result of any one or more of the following:
 - (I) Normal wear and tear,
 - (II) Accident, disaster, or event of force majeure,
 - (III) Misuse, fault, or negligence of or by any user or other person,
 - (IV) Use of the J- Smart Pro in a manner for which it was not designed,
 - (V) Causes external to the J- Smart Pro such as, but not limited to, power failure, electrical power surges, exposure to fire, water, other liquids, excessive humidity or temperature, virus software attacks,

14.3 Terms and Conditions

14.3.1 Definition

In this document the following words shall have the following meanings:

- "Buyer" means the organization or person who buys Goods.
- "Goods" means the articles to be supplied to the Buyer by the Seller.
- "Intellectual Property Rights" means all patents, registered and unregistered designs, copyright, trademarks, know-how and all other forms of intellectual property wherever in the world enforceable.
- "Seller" means an individual or entity that exchanges any type of good or service in return for the payment.

14.3.2 General

• These Terms and Conditions shall apply to sales of Goods by the Seller to the Buyer to the exclusion of all other terms and conditions referred to, offered or relied on by the Buyer whether in negotiation or at any stage in the dealings between the parties, including any standard or printed terms tendered by the Buyer, unless the Buyer specifically states in writing, separately from such terms, that it wishes such terms to apply and this has been acknowledged by the Seller in writing. Any variation to these Terms and Conditions (including any special terms and the conditions agreed between the parties) shall be in applicable unless agreed in writing by the Seller.



14.3.3 Order

• Order is only valid once 30% deposit received. Once the buyer fills the complete order-form, a Performa Invoice will be generated through which the buyer needs to pay 100% of the price of the goods.

14.3.4 Price & Payment

- The price shall be the Recommended Retail Price less agreed discount, unless otherwise agreed in writing between the parties. The price is exclusive of VAT or any other applicable taxes.
- Credit terms may be offered subject to satisfactory credit vetting of the Buyer by the Seller. The offer of credit will be at the sole discretion of the Seller.
- Where credit is offered payment of the price and VAT and any other applicable taxes shall be due within 15 days of the date of the invoice supplied by the Seller, unless otherwise agreed in writing. In cases where credit is not offered payment will be required before release of goods by the Seller.
- The Seller shall be entitled to charge interest on overdue invoices from the date when payment becomes due from day to day until the date of payment at a rate of 12 per cent per annum.
- If payment of the price or any part thereof is not made by the due date, the Seller shall be entitled to:
 - o Require payment in advance of delivery in relation to any Goods not previously delivered.
 - Refuse to make delivery of any undelivered Goods without incurring any liability whatever to the Buyer for non-delivery or any delay in delivery.

14.3.5 Description

• Any description given or applied to the Goods is given by way of identification only and these of such description shall not constitute a sale by description. For the avoidance of doubt, the Buyer hereby affirms that it does not in any way rely on any description.

14.3.6 Delivery

- Unless otherwise agreed in writing, delivery of the Goods shall take place at the address specified by the Buyer on, or as close as possible to the date required by the Buyer. The Buyer shall make all arrangements necessary to take delivery of the Goods whenever they are tendered for delivery.
- If the Seller is unable to deliver the Goods because of actions or circumstances under the control of the Buyer, then the Seller shall be entitled to place the Goods in storage until such times as delivery may be affected and the Buyer shall be liable for any expense associated with such storage.
- Any damages, shortages, over deliveries and duplicated orders should be reported to the Seller within 14 days of signed receipt to enable replacement or refund.
- Delivery is strictly based on First come First Serve bases and sole discretions of DRC.

14.3.7 Risk

 Risk in the Goods shall pass to the Buyer upon receipt of the goods. Where the Buyer chooses to collect the Goods itself, risk will pass when the Goods are entrusted to it or set aside for its collection, whichever happens first.

14.4 Title

Title in the Goods shall not pass to the Buyer until the Seller has been paid in full for the Goods.

14.4.1 Return of Unused Goods

- All goods are sold on a firm sale basis, i.e. the Seller will not take back any goods not required or sold by the Buyer, unless otherwise agreed, in which case the following terms apply.
- Any returns must be authorized by a representative of the Seller before any credit will be given.
- Credit of amount due or paid-in will only be given for goods that are in saleable condition.

14.4.2 Limitations of Liability and Warranty

• Warranty is void if the device is tampered / physically damaged / dispersed or dissipated by other than the authorized technician; will full damage is offensive under IP law.



14.4.3 Intellectual Property Rights

 All Intellectual Property Rights produced from or arising as a result of the performance of this Agreement shall, so far as not already vested, become the absolute property of the Seller, and the Buyer shall do all that is reasonably necessary to ensure that such rights vest in the Seller by the execution of appropriate instruments or the making of agreements with the third parties.

14.4.4 Force Majeure

• The Seller shall not be liable for any delay or failure to perform any of its obligations if the delay or failure results from events or circumstances outside its reasonable control, including but not limited to acts of God, strikes, lock outs, accidents, war, fire, breakdown of plant or machinery or shortage or unavailability of raw materials from a natural source of supply, and the Seller shall be entitled to a reasonable extension of its obligations. If the delay persists for such time as the Seller considers unreasonable, it may, without liability on its part, terminate the contract.

14.4.5 Relationship between Parties

Nothing contained in these Terms and Conditions shall be construed as establishing or implying any
partnership or joint venture between the parties and nothing in these Terms and Conditions shall be
deemed to construe either of the parties as the agent of the other.

14.4.6 Assignment and Sub-Contracting

• The contract between the Buyer and Seller for the sale of Goods shall not be assigned or transferred, nor the performance of any obligation sub-contracted, in either case by the Buyer, without the prior written consent of the Seller.

14.4.7 Waiver

• The failure by either party to enforce at any time or for any period any one or more of the Terms and Conditions herein shall not be a waiver of them or of the right at any times subsequently to enforce all Terms and Conditions of this Agreement.

14.4.8 Severability

• If any term or provision of these Terms and Conditions is held invalid, illegal or unenforceable for any reason by any court of competent jurisdiction such provision shall be severed and the remainder of the provisions hereof shall continue in full force and effect as if these Terms and Conditions had been agreed with the invalid, illegal or unenforceable provision eliminated.

14.4.9 Governing Law and Jurisdiction

• This Agreement shall be governed by and construed in accordance with the laws of India and the parties hereby submit to the exclusive jurisdiction of Surat district court.

14.5 Privacy

- Buyers/Users of this device must keep it periodically connected to the internet to receive regular over the air software updates.
- Buyers/Users are not allowed to resell without prior permission, J- Smart Pro is running on an online validation process: the system will stop working if owner details do not correlate.
- Buyers of the device must register themselves with a UID (User Identifier) provided & listed with each device. The purpose of UID is to maintain a chain of custody. UID and scanning data may also be used to protect the user from fraudulent claims.



14.6 Machine Maintenance policy

- Following is the significance of the maintenance policy:
 - o It ensures that the equipment is always operational and in the best working condition.
 - o It ensures that the equipment is always maintained and calibrated to provide good result.
 - o It ensures that your operators should be aware with the machine software and its operations.
 - o It ensures to maintain proper earthing, power supply and spacing (for ventilation) as per the machine standard.
- If any organization does not implement an effective maintenance policy, then it can result in the following results:
 - o It reduces the production time.
 - o It reduces the machine efficiency.
 - o It requires increased, more frequent maintenance/service.
 - o Parts may be damaged before their expected life.
 - o The overall machine accuracy may be compromised.

14.7 Machine Service policy

14.7.1 Online Troubleshooting

- Client must have a High-Speed internet facility for the service support.
- Online service support will help you to troubleshoot on the basis of the virtual analysis.
- Online service support will help you to find out the cause of the problem.
- Online service support will try to resolve the problems through online but in rare cases it needs the engineer visit for further troubleshooting.

14.7.2 Physical Troubleshoot

- Customer Premises (Engineer visit)
 - o Our engineer will inform the client for critical/non-critical damaged parts in machine.
 - o Our engineer will inform/alert the client that which parts would get expired in future.
 - o Our engineer will guide you how to maintain external accessories and standard to be maintained.
 - o During Machine health check-up visit, our engineer will provide you detailed report.

Company Premises (DRC Office)

 During in house service if additional parts found to be damaged in machine, then it will be replaced after getting the confirmation from the client.

Machine Transfer Policy

o If any client will sell or transfer the product, then client must have provided the supportive legal documents to the DRC for continuing service support.

14.8 Using Third Party Apps and Service Policy

- At the time of troubleshooting, client must have enabled all the permissions and removed security restrictions from the machine.
- DRC will not take the responsibility of the accidental data loss, due to a third party product that has stopped or malfunctioned. (i.e. Corrupted MS Windows and HDD and accidental data loss.) We always recommend that users backup their data for safety and security.
- Third-Party app requires the permission and continuous attention for smooth operation.
- MS Windows security may inhibit third-party applications and their services which may require the user to update MS Windows software as well the third party app time to time.
